# The Festival on the Avenue Vendor's Agreement



1. The cost for a vendor's space for the Festival on the Avenue will be \$175 per space. Twenty-five dollars can be refunded if the rules below are followed.
2. By agreeing to purchase a space for the festival, I will agree to abide by the following rules:
  - a. I will accept the space assigned to me by the committee.
  - b. I will not move to another space unless the change is made by the committee.
  - c. If I change without the committee's approval, I will forfeit the opportunity to participate as a vendor at the festival.
  - d. Due to the festival ending at 4:00 p.m., I will begin cleaning my space promptly at 3:00 p.m. Saturday. This will allow city officials to have the trash picked up so the streets can be opened to normal traffic by 4:00 p.m. (If you do not leave by 4:00 you will not be allowed to participate next year.)**
  - e. I will also make sure that all trash accumulated during my stay at the festival is cleaned up and removed before I depart. If this is not done, I will forfeit my \$25.00 deposit for the festival which will be used to pay to have space cleaned.
  - f. All refunds will be made on Thursday, **April 30, 2020** at the South Sumter Resource Center from **5:00 p.m. - 6:00 p.m.**
  - g. If any of the above rules are violated, I will forfeit the opportunity to participate in future festival events.
